Description

Trade-Seals are a one piece self adhesive collar for sealing around pipe and service penetrations that penetrate through wall underlays. The collar has a an aggressive adhesive that bonds to the underlay, The outer face of the collar is water repellent, tear resistant. The EPDM grommet forms a positive seal around the thru-wall penetration.

Scope of use

Trade-Seals are used as a pipe and service penetration seal for use where pipes and service penetrations penetrate the wall underlay on timber & steel frame buildings within the following scope; The scope limitations of NZBC Acceptable Solutions E2/AS1, paragraph 1.1; and • With BRANZ & CodeMark Appraised / Certified flexible and rigid underlays; and, • Situated in NZS 3604 Wind Zones up to, and including, Extra High.

Conditions of use

The system must be installed in accordance with the specifications and latest technical information and must comply with all relevant clauses of the NZBC regulations and standards TRADE-SEALS are UV stable for 90 days. The EPDM boot must not be exposed to UV.
